With respect to the Synergy representatives, who I would guess would include Thom Zauqq, you have my permission to discuss

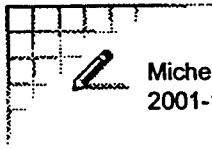

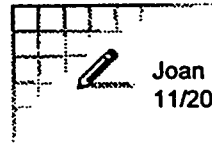
