

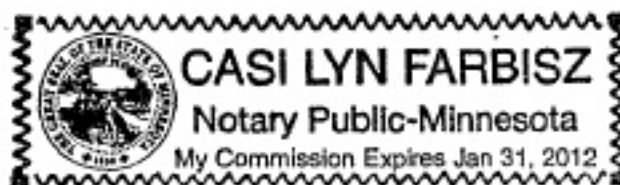
CHARLES A. GROSS, being duly sworn, on oath, states:

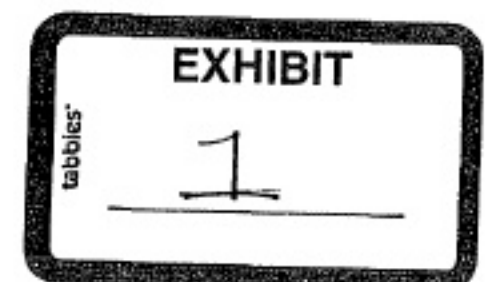
