8           The above captioned matter came before the Arizona  
9 Board of Osteopathic Examiners in Medicine and Surgery (Board)  
10 for hearing on January 11, 1985, pursuant to A.R.S. §§ 32-1801  
11 et seq. and §§ 41-1001 et seq. The State of Arizona was  
12 represented by Virginia Balmes Whitehead, Assistant Attorney  
13 General. Repondent ROBERT B. WICKMAN, D.O. was not present and  
14 no one appeared on his behalf. The Board having considered all  
15 the matters presented and being fully advised, makes the follow-  
16 ing Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

I

23           The Arizona Board of Osteopathic Examiners in Medicine  
24 and Surgery is the duly constituted authority for the regulation  
25 and control of the practice of osteopathic medicine and surgery  
26 in the State of Arizona.

II

27           On February 17, 1964, ROBERT B. WICKMAN, D.O. was  
28 issued License No. 687 for the practice of osteopathic medicine  
29 and surgery in the State of Arizona.

III

In June and July, 1983 ROBERT B. WICKMAN, D.O. maintained a referring and fee dividing relationship with one Ken Anderson, an illegal practitioner of medicine.

IV

On or about July 11, 1983 ROBERT B. WICKMAN, D.O. fraudulently represented to Sandra Ramsey, an undercover investigator that a solution of L-Arginine (identified as Tumorex) and DMSO was an effective and successfully curative treatment for cancer.

V

On or about July 11, 1983 ROBERT B. WICKMAN, D.O. offered to and embarked on a course of conduct that, if carried to its intended conclusion, would have resulted in the treatment of Sandra Ramsey by injection with a solution of DMSO and Tumorex, without first taking a history, conducting a physical examination, or arriving at a diagnosis of any medical condition in Ms. Ramsey.

VI

On or about July 11, 1983 ROBERT B. WICKMAN, D.O. accepted a fee of \$2,500.00 in cash in return for an agreement to treat Sandra Ramsey with a solution of DMSO and Tumorex.

VII

On or about July 11, 1983 ROBERT B. WICKMAN, D.O. offered to provide Sandra Ramsey with a cash receipt made out as

1 if received from the "Basic Bible Church" for the cash payment  
2 she tendered for treatment with DMSO and Tumorex.

3 VIII

4 On or about June and July of 1983 ROBERT B. WICKMAN,  
5 D.O. conspired with one Ken Anderson to engage in the violations  
6 described above in Paragraphs III through VII.

7 IX

8 ROBERT B. WICKMAN, D.O. failed to comply with the  
9 Board's request to appear at the informal interview held on  
10 October 19, 1984 regarding the use of colonics to treat rectal  
11 bleeding when a diagnosis had not been made and the use of  
12 "Chelapex" oral chelatin treatments without proper examination  
13 and diagnosis. The informal interview originally scheduled for  
14 the Board's August 1984 meeting was continued to the October  
15 meeting at the request of Dr. Wickman's attorney. The Board  
16 received no indication of the reason Dr. Wickman or a  
17 representative did not appear at the October meeting.

19 ROBERT B. WICKMAN, D.O. failed to provide the Board  
20 with requested information concerning "Cheleplex" treatment.

21 CONCLUSIONS OF LAW

22 XI

23 A.R.S. § 31-1855(M) provides that any osteopathic  
24 physician who after a hearing is found by the Board to be guilty  
25 of unprofessional conduct shall be subject to any one or more of  
26 the following: civil penalty, censure, probation, suspension of

1 license, or revocation of license, and for such period of time,  
2 or permanently, and under such conditions as the Board deems  
3 appropriate for the protection of the public health and safety  
4 and just in the circumstances.

5 XII

6 The violation described in Paragraph III constitutes  
7 unprofessional conduct as defined by A.R.S. § 32-1854(A)(11).

8 XIII

9 The violation described in Paragraph IV constitutes  
10 unprofessional conduct as defined by A.R.S. § 32-1854(A)(16).

11 XIV

12 The violation described in Paragraph V constitutes  
13 unprofessional conduct as defined by A.R.S. § 32-1854(A)(20).

14 XV

15 The violation described in Paragraph VI constitutes  
16 unprofessional conduct as defined by A.R.S. § 32-1854(A)(28) &  
17 (20).

18 XVI

19 The violation described in Paragraph VII constitutes  
20 unprofessional conduct as defined by A.R.S. § 32-1854(A)(18).

21 XVII

22 The violation described in Paragraph VIII constitutes  
23 unprofessional conduct as defined by A.R.S. § 32-1854(A)(21).

The violation described in Paragraphs IX and X constitutes unprofessional conduct as defined by A.R.S. § 32-1854(A)(14).

XIX

In light of the foregoing Findings of Fact and Conclusions of Law, grounds exist to permanently revoke the osteopathic medical license of ROBERT B. WICKMAN, D.O.

ORDER

Upon motion duly made, seconded and unanimously carried, License No. 687 for the practice of osteopathic medicine in the State of Arizona held by ROBERT B. WICKMAN, D.O. is hereby permanently revoked.
