At its meeting on April 22, 1995, the ACAM IRB adopted a change to the phraseology required in the informed consent document upon the advice of legal counsel. In Paragraph (8) of the *Informed Consent, Disclosure and Acknowledgement Form for Chelation Therapy Study* the word "such" has been deleted from the final sentence. The last phrase of that sentence should now read ".....and I waive, in advance, any claims against either and both of them."

Please insure that your informed consent documents are corrected to reflect this change.

Enclosed for your information is the applicable page from the *Informed Consent, Disclosure and Acknowledgement Form for Chelation Therapy Study* showing the correction as well as page 8 of the *IRB Investigational Project Guidelines* with the change noted.
